### Directions for use

Shake well before use. Hold upright and spray 20 cm from surface. Wipe over with a clean damp cloth, rinse and leave to dry. For stubborn stains apply directly to problem affected areas and leave for 15-20 minutes before agitating and rinsing.

### Notes

Contains an lime scale remover and inhibitor. Reduces the tendency of surfaces to mist up. Suitable for both domestic and commercial kitchens and bathrooms

Not suitable for use on surfaces that have been sealed.
